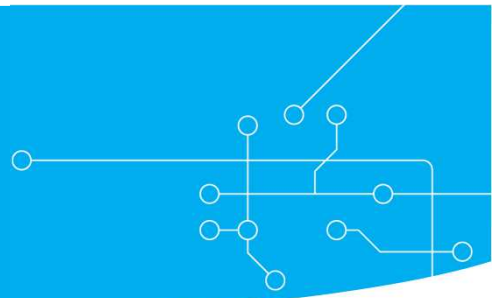
### Access to Resources
