- 4.1% annual growth despite economic downturn. Revenue expected to double by 2020. Main growth areas : forensics & cyber
- 61,500 jobs, of which 13,400 in The Hague region. 25% more jobs expected by 2020
- The Hague region strongly represented in non-traditional security (e.g. cyber security) in terms of turnover and number of jobs.

National Innovation Centre for Security

In February 2014, the Dutch Minister of Security & Justice opened the HSD Campus, the national innovation centre of the security cluster with state-of-the-art labs for serious gaming , real-time intelligence and incident experience, education and training facilities, flexible office space, and meeting rooms.



Examples of Innovations in The Hague Security Delta

Smart Secure Zones

The Hague hosts 131 international institutions. Many of them, including Europol and the Yugoslav War Crimes Tribunal, are located in the so-called international zone. In March 2014, the global Nuclear Security Summit took place in this district of The Hague. At present, every building and organization deploys and builds its own security measures (for example buffer zones, guards, monitoring systems). With the current state of technology, this can be done more efficiently, and with less inconvenience to local residents and visitors. Partners in HSD are therefore developing a 'real-time intelligence lab' in the HSD Campus (national security innovation centre) as an experimental facility for integral protection of the whole international zone.

CSI The Hague

The Netherlands Forensic Institute (NFI) has developed a revolutionary Crime Scene Investigation (CSI) Lab, a demonstration and training facility to investigate a virtual crime scene. Forensic investigators first record the actual crime scene with 3D scans, exactly as the police encountered the situation. Afterwards, all the data can be re-examined virtually in the CSI lab. This makes it possible to test new hypotheses on the facts even years later. CSI Lab uses existing techniques from fields such as aviation, medical science and the game industry. In 2013, NFI was contracted by the South African government to develop CSI Capetown, a copy of the CSI Lab in The Hague.
